Water System Projects

On Saturday, December 4, 2009 The MRPOA Board was invited by Wigwam Mutual Water Company to tour the two well heads (one active, one under construction), which both will ultimately provide water for Midway Ranches.

At the meeting, Wigwam Mutual Water Company disclosed planned improvements. A total of ten different improvement projects are planned, two of which are located within Midway Ranches.

The first Midway Ranches project is to install an additional 30,000 gallon water storage tank next to the existing one on Antelope Rd. The original permits, plans, engineering, etc. already allowed for a second tank. Only a concrete pad and constructing the tank is required.

The second project is to install fire hydrants at each intersection on Young Hollow.

Wigwam Mutual Water Company has researched some grants and low interest loans and feel it is in Midway Ranches' advantage to re-finance our current debt and make these improvements.

Wigwam Mutual Water Company would like to schedule an open meeting for the Midway Ranches landowners in the near future. The Board wants to make sure everyone understands this is not an attempt by Wigwam Mutual Water Company to "take over" the Midway Ranches water system, but a partnership to improve our water system.

When the contract for fire protection was signed with Hanover Fire, an included benefit was mutual aid. Hanover Fire Department has made agreements with the surrounding fire departments to help.

Fountain, Security / Widefield, Colorado Springs, Elicott, Edison, Pueblo West & Fort Carson.
